Co-Chairs J Davis and Laura Downey virtually attended the MRSPA Legislative Committee meeting held on Aug. 27, 2024.

Last year, the MRSPA Legislative Committee reviewed 61 bills. It voted to support 31, to oppose 14, and to monitor the rest. The Annual Legislative Workshop will be Jan. 28, 2025, at 10 AM. It will be held virtually due to budgetary constraints and health concerns. An in-person Lobby Day is being considered; however, cost and possible lack of space might keep this from occurring.

Next year's State Legislative Session will be difficult as a large budget deficit is predicted. Gov. Moore is currently streamlining and culling task forces and committees which number over 300. He has also delayed several planned transportation projects.

The MRSPA Legislative Committee reviewed and approved its legislative priorities for next year. Some priorities are changing caregiver grants to tax credits, creating tax credits for long term care costs, and having all drugs reviewed for possible cost reduction, not just a select few. 

PGPSRA Community Service Committee September/October 2024

The Community Service Committee is off and running! The committee will focus on a variety of new service projects, while continuing to support select schools in the district.

This year, the committee will engage in a program to support the children and women at Shepherd's Cove Shelter in Capitol Heights, Maryland. Once per month beginning in October 2024 and ending in May 2025, the committee will engage the children in math, reading, and arts activities that will be fun while reinforcing core learning skills. For the month of October, the theme for the children is "Johnny Appleseed". The women at the shelter will engage in a variety of activities that will support their mental, physical, social, and emotional growth. The October theme for the women residents is "Changing Seasons, Changing You". The guest motivational, inspirational speaker will be Dr. Sonia L. King.

The committee will also be providing support to three schools in the southern area of the county: Panorama Elementary, Princeton Elementary, and Suitland Elementary. Central High School will also be supported through the financing of senior fees for at least 3 needy, but well deserving students. Meetings with the Principals, Guidance Counselors, and/or Community School Coordinators have already taken place and donations of uniforms and school supplies have been provided to all three Elementary Schools. We are very grateful to Dr. Carolyn Cuff for partnering with the Community Service Committee in providing some of the donations that we have provided to the schools.

The committee is very appreciative to all PGPSRA members who have donated books, current magazines, and 2025 calendars to our project led by Lillie James in partnership with the Friends of the Library, Oxon Hill.
